THESE TWO PROGRAMS ARE CONSOLIDATED WITH THE FOSTER COMPONENT INCURRING THE EXPENSES AND THE ADOPTION PROGRAM GENERATING THE REVENUE. A TOTAL OF 114 ANIMALS WERE ADOPTED IN 2025.
